PROGRAM OVERVIEW

Buy any handheld STIHL Battery KombiSystem tool together with any STIHL Lithium-Ion battery and charger, from any participating STIHL dealer in the BME Territory (Texas, Oklahoma), through June 30, 2014, and you qualify for a \$70 mail-in rebate. Purchase any STIHL Battery KombiSystem tool with any STIHL Lithium-Ion battery (but no charger), and you qualify for a \$50 mail-in rebate. Completed rebate requests must be postmarked by July 31, 2014. Please allow 6-8 weeks to receive your rebate.

CLAIM PROCEDURE

\$70 Mail-in Rebate: Qualifying purchases include a STIHL Battery KombiSystem tool: HSA 65 and/or 66 hedge trimmers; HLA 65 extended reach hedge trimmer; FSA 65 and/or 85 trimmers; MSA 160 C-BQ and/or 200 C-BQ chain saws; BGA 85 blower; or RMA 370 lawn mower when purchased with a STIHL AP 80, AP 160, AP 180 or AL 900 battery AND STIHL Lithium-Ion charger (AL 100, AL 300, or AL 500).

\$50 Mail-in Rebate: Qualifying purchases include a STIHL Battery KombiSystem tool and STIHL Lithium-Ion battery (listed above).

Simply follow the instructions on the "STIHL Battery KombiSystem Rebate Offer" form to submit your rebate claim. Proof of purchase and additional information are required.

For questions about claiming a rebate under this promotion, see your authorized STIHL dealer. Rebate checks will only be mailed to an address located within the 50 United States, the District of Columbia, or other US Territory. It may take 6-8 weeks after submission of a completed rebate claim, made in accordance with these terms, to receive your check.

PROOF OF PURCHASE

For purchases from your participating STIHL dealer, proof of purchase is a copy of your STIHL dealer's sales receipt (not a copy of your credit card receipt), which clearly shows the dealer name and address, STIHL Battery KombiSystem tool model number and serial number, battery model number and battery serial number, and date of purchase and invoice number, as well as your full name and address and phone number.

PROCEDURES RELATED TO PRODUCT RETURNS UNDER THIS PROMOTION

If any Qualifying Product required for redemption is returned for any reason, your rebate claim and any checks issued to you under this promotion will not be honored.

Purchase a qualifying STIHL Battery KombiSystem tool together with a qualifying STIHL Lithium-Ion battery and charger through June 30, 2014, from a participating CDC-BME STIHL dealer and receive a mail-in rebate of \$70. Purchase a qualifying STIHL Battery KombiSystem tool and a qualifying STIHL Lithium-Ion battery and receive a mail-in rebate of \$50 (subject to terms and conditions). Claims must be submitted and postmarked by July 31, 2014.
